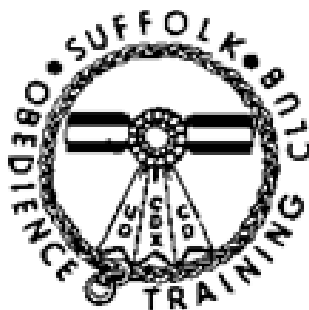

SITE INFORMATION

Due to site limitations, there will be no setting up of personal effects on Saturday, February 11th. The Training Center will open at 7:00 AM on Sunday, February 12th for individual crating. **PLEASE DO NOT ARRIVE PRIOR TO 7:00 AM, AS YOU WILL NOT BE PERMITTED TO ENTER THE BUILDING UNTIL 7:00 AM.**

Please stack crates if possible. **NO EX-PENS.**

Please park in the designated parking area next to the building and in the adjacent parking lots.

There is a designated “potty” area. Please clean up after your dog and place waste in the receptacles provided by the club. **DO NOT** use any dumpsters or allow dogs to urinate on the buildings.

Snacks and beverages may be available for sale. However, there are numerous food vendors within walking distance of the facility.

NOTICE TO EXHIBITORS

Exhibitors should follow their veterinarian’s recommendation to assure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations.

No Bitches in season allowed. Refunds less \$10.00 administrative fee will be made for bitches that come into season after the closing date of the trial. A written request must be made accompanied by a letter from a veterinarian within 24 hours of trial completion.

Judges are not required to wait for dogs. Exhibitors are solely responsible for getting their dogs to the ring on time. Consult judging program for time of judging.

Dogs may arrive any time prior to their scheduled time of judging. Dogs not required for further judging will be excused.

Judges will not wait for any dog holding up a class. Owners or agents are responsible for the presence of their dogs in the judging ring when their classes are called to be judged. The show-giving club has no obligation or responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

All dogs present must be held on leash or confined to their crates except when being judged.

The Show Committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, nor assume any liability in the event of an accident or misfortune to either dogs or exhibitors participating in this show.

To find out about any AKC event cancellations call the AKC Event Cancellation Hotline 877-252-3229. Entry shall not be refunded in the event that a dog is absent, disqualified, excused by a veterinarian or judge or barred from competition by the trial committee. If, because of riots, civil disturbances, or other acts beyond the control of the management, it is impossible to open or complete the trial, no refund of entry fees shall be made.
